Hong Leong Islamic Bank – Travelog 2017 Contest

Terms and Conditions ("T&Cs")

"Hong Leong Islamic Bank Travelog 2017" ("Contest") is a social media contest organised by Hong Leong Islamic Bank Berhad ("the Bank") which commences from 2nd to 20th October 2017 ("Contest Period") the date of the Contest Period is inclusive, unless otherwise notified.

Eligibility

- 1. The Contest is open to all individual Customers of the Bank who are Malaysian and non-Malaysian Residents, and non-Customers of the Bank excluding the Bank's permanent and contractual employees ("Participants").
- 2. For non-Malaysian Participants, the Participants must reside in Malaysia during Contest Period and continue to reside in Malaysia one (1) month after the end of the Contest Period.

Contest Mechanics

 - (a) The destination must be within Malaysia inclusive Sabah and Sarawak only;
 - (b) The starting point of the road trip must be in a different state than the destination and must be completed not exceeding twenty four (24) hours from the departure time to the end of the road trip;
 - (c) The return road trip costs must not exceed Ringgit Malaysia Five Hundred (RM500) excluding air fare (if any);
 - (d) The proposal must include HLISB Debit Card-i usage in at least two (2) occasions throughout the road trip;
 - (e) The Participants may submit their proposal individually or in group of two (2) persons in the form of a write-up together with a copy of the Participant's passport picture, nick name, full name as per IC and email address;
 - (f) Submission can be in Bahasa Malaysia or English in Microsoft Office Word or Power-Point, PDF or picture format.

- 6. For the avoidance of doubt, the Contest Entries submitted that is not complete as per stipulated in Item 4 and/or which are not accessible by the Bank would not be considered as valid or successful Contest Entries.
- 7. The Bank accepts no responsibility for any unsuccessful Contest Entries caused by submission uploaded which contains any racist sentiments, profanities or any other elements deem inappropriate by the Bank or due to any technical or internet connectivity issues faced by the Participants.

Prizes & Winners Selection

- 8. Participants who have performed and fulfilled the requirements set out in Clause 4 to Clause 6 above ("Successful Contest Entries"), are eligible for selection by the Bank to win the Prizes during the Contest Period ("Winners").
- 9. Three (3) Winners will be selected based on most creative and interesting road trip proposal at the end of the Contest Period.
- 10. The winners will each win a personal 'Travelog' show produced by the Bank based on the Road Trip proposed by the Winners ("Contest Prize").
- 11. The Contest Prize which is a 'Travelog' show consists of the following:-

- (a) A team of videographers (video crew) to film the Winner hosting their road trip as per the Successful Contest Entries;
- (b) A cost of RM500 shall be credited into the Winners Hong Leong Islamic Bank Current Account-i or Savings Account-i ("CASA-i") prior to the road trip as part of the travelling cost and for the usage of HLISB Debit Card-i during the road trip;

 - (e) Hong Leong Islamic Bank Savings or Current Account Number.
- 18. If the any of the Winners fail to respond to the Bank in manner and with all details required in Clause 17 above the Winners shall be deemed to have been disqualified from the Contest and shall not be entitled to the Prizes.
