

## **RAYA 2024 TAKAFUL REGULAR CONTRIBUTION PROMOTION**

### **PROMOTION PERIOD**

Hong Leong Islamic Bank Berhad's (200501009144 (686191-W)) ("**HLISB**" or "**the Bank**") **Raya 2024 Takaful Regular Contribution Promotion ("Promotion")** commences on 25 March 2024 and ends on 9 May 2024, both dates inclusive ("**Promotion Period**"), unless notified otherwise.

### **TERMS & CONDITIONS**

The following sets out the terms and conditions applicable to the Promotion ("**T&Cs**").

### **ELIGIBILITY**

1. The Promotion is open for participants ("**Customers**") who sign up for HLM Takaful Amanah Saver, HLM Takaful Legacy / Legacy Plus or HLM Takaful Secure 3 / 3 Plus ("**Plan**"), a product underwritten by Hong Leong MSIG Takaful ("**HLMT**") at any HLISB or Hong Leong Bank Berhad ("**HLB**") branches during the Promotion Period.
  
2. In order to participate in this Promotion and be eligible for the sign-up gifts, Customers are required to fulfil the conditions below:
  - (a) Customer must sign up for any one of the Plans as stated in Clause 1;
  - (b) Must have active current account/current account-i or savings account/saving account-i ("**CASA/CASA-i**") opened and maintained with HLB and/or HLISB;
  - (c) The contribution payment frequency for the Plan must be on an annual basis;
  - (d) The minimum annualized contribution amount must be at least Ringgit Malaysia Ten Thousand (RM10,000); and

4. HLISB will credit the Reward into the Winner's ("**CASA/CASA-i**") within ninety (90) days from the date the certificate turns into production based on the list provided and confirmed by HLMT.
