Special Online Current / Savings Account-i (eCASA-i) Offers Up to RM50.00 Cash Back

PROMOTION PERIOD

Hong Leong Islamic Bank Berhad's (686191-W) ("HLISB") "Special Online Current / Savings Account-i Offers (eCASA-i) **Up to RM50.00**" ("the Promotion"), commences from 14 May 2018 to 30 June 2018, both dates inclusive unless otherwise notified ("Promotion Period").

Terms and Conditions

The following sets out the terms and conditions applicable to the Promotion ("T&Cs"):

Eligibility

- 1. The promotion is only open to selected Individual customers including Malaysian and non-Malaysian ("Selected Customers") who receive an invitation to participate in this Promotion via electronic Direct Mailer (eDM) and/or Short Messaging Services (SMS) from HLISB during the Promotion Period.

- 3. The following Selected Customers are NOT eligible to participate in the Campaign:

- 5. Selected Customers are eligible for cash back of RM30.00 (Cash Back) if he/she successfully opensary of the Participating Accounts at any of HLISB or HLB branches with minimum intial deposit of RM200.00 during the Promotion Period.
