JUNIOR SAVINGS ACCOUNT-i 2019 PROMOTION

PROMOTION PERIOD

Hong Leong Islamic Bank Berhad's (686191-W) ("HLISB") "Junior Savings Account-i 2019 Promotion" ("Promotion"), commences on 15 April 2019 and ends on 31 July 2019, both dates inclusive ("Promotion Period") unless notified otherwise.

Terms and Conditions

The following sets out the terms and conditions applicable to the Promotion ("T&Cs"):-

ELIGIBILITY

- 1. The Promotion is open to all new and existing individual primary accountholders of Junior Savings Account-i ("Accountholders"), including Priority Banking, and Private Banking ("Customers").
- 2. For avoidance of doubt:-
 - (a) "New Accountholders" refers to Customers who do not have a Junior Savings Account-i ("JSA-i") with HLISB prior to the Promotion Period and open a JSA-i during the Promotion Period;
 - (b) "Existing Accountholders" refers to Customers who has a JSA-i prior to Promotion Period.

- 4. 9. The participating account must remain open, active and valid with a minimum account balance of Ringgit Malaysia Five Hundred (RM500) during the Promotion Period and until 30 November 2019 for the purpose of the contest fulfilments.

- 10. In the event the participating account are closed due to any reasons whatsoever on or before 30 November 2019 (which includes at any time during the Promotion Period), the Winners shall be disqualified from receiving the contest prize.
