- 7. In order for Eligible Customers to earn Additional Contest Entries, Eligible Customers must perform one of the Contest Criteria in **Table A** above **AND** one of the Criteria in **Table B**.
- 8. For the purpose of this Contest, the deposit must be New Funds. For avoidance of doubt, New Funds are defined as:
 - (a) Cash, interbank GIRO, new funds received via telegraphic transfer from other banks, local cheque or banker's cheque issued by other banks which are deposited into Participating CASA-I; and
